English would be taught and encouraged as part of the citizenship with a very clear reasoning that, "English is a necessary language for new US citizens in order to gain good jobs and negotiate like every other English-speaking American may negotiate throughout America and, of course, as they deal with the world and advance with military & business" connected with the Mealer Economic Initiative. Foreign felons and child molesters will never be accepted into the US, as according to current law, so by this method, it may be assumed that any migrant NOT registering to begin the Visa and/or citizenship status is not a practical choice for US citizenship or visa status in the future and will be deported to their country of origin. If that country no longer exists, will be sent to the soil of that where

that country once existed or placed into the US legal system for consideration of rehabilitation, or justice.

Oddly, more than half of all Americans (most calling themselves Conservative) cannot or will not comprehend the fact that many migrant workers and other illegal aliens have worked in the US for decades and have paid their withholding taxes, as well as paying local property taxes (in rent or otherwise) and fuel taxes and sales tax, yet have no ability to apply for a state or federal income tax refund, welfare or unemployment benefits (when needed). This being the case, the very idea that the "evil, welfare receiving, illegal aliens with their anchor babies" and children are entering the schools for free is absurd and flat-out wrong. We have grown up as friends and acquaintances with many of these undocumented worker's children.

Coming down hard on those who hire undocumented workers is a must, because without, at the very least, using E-Verify and other more carefully constructed safe hiring programs we may as well forget border protection. If the US is to perceive to control illegal immigration and unlawful hiring practices, we have no other option besides mass deportation. Which is not a viable option due to the overwhelming cost.

Mega-corps (aka.; transnational conglomerates who destroy American small business) are taking advantage of lower wages and heavy workload [IE. slave labor)] and essentially support human smuggling because that is what the hiring of undocumented workers is all about in the business world.

Of course, to protect the unwary investor, protections that allow them to stay at arms length of the legal ramifications of illegal hiring, a variety of employee check points must be available and in place. This is what board meetings are all about and allows any business owner to know exactly what is going on in his or her business.

When a company profits from the exploitation of the American workforce, by hiring undocumented workers, everyone but the employer loses. Simply put, this must not continue!

Special Interest groups, lobbyists and the current status quo running Washington DC today will no longer be tolerated. Corporations that hire undocumented workers ideally will not be fined or punished, INSTEAD after multiple violations and a series of fines, the business must be seized by the US and business assets confiscated. It's time to pay attention and use E-Verify before investing in criminal activity and reckless business environments.

Due to the human trafficking and human rights violations, not to mention the corruption created that has destroyed America's workforce, all board members, managers, company investors or profiteers as participants in criminal activity **resulting in** murder, racketeering, gross child abuse, endangerment, human trafficking, etc. must be held accountable. This alone will put a stymie on border town drug violence and import-export black marketed goods that are invading our country and further destroying American investment in American businesses.

This is a National Security risk and must be treated as such.

United States; AND paragraph 9: To constitute Tribunals inferior to the supreme Court; AND distinctly in paragraph 21: To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof.

In many cases, the Mexican, Colombian, Afghanistan, et al. drug cartels are capturing and/or hiring desperate and uneducated children who have no other opportunities to run the cartel's drugs and to kill when commanded. They occasionally grow past puberty and become scum-of-the-earth killers. This, of course, leads to the current drug wars and border wars that are creeping into the USA.
